Boat Ramp Park Problems & Concerns

At our most recent PBCA board meeting word surfaced that the county was going to reduce operating hours at the boat ramp park to sunrise and sunset plus a gate was going to be installed. Several members of our board expressed strong resistance to such a move. Some of the board members then called for a community meeting at the park the following Sunday afternoon. Word of the planned changes quickly spread through the community via social media. Ms. Carolyn Ketchel, our county commissioner was inundated with emails expressing sentiment against the planned changes to the park. To her credit, she thought the changes were something the community wanted and when she found out the opposite, she quickly corrected the move. No changes to park hours and no gate. Now you need to spend a few minutes and read what one neighbor of the park has to say about activities in our park at all hours.

County Ordinance Regarding Parks Hours of Use in Okaloosa County.

Sec. 16-52. - Hours of use. All county parks, including river and beach access points, shall be closed between one hour after sunset and one hour before sunrise. No person, firm, corporation, joint venture, partnership, or other legal entity shall enter, occupy, trespass or use any county park in Okaloosa County during the time that the same is closed to the public pursuant to the signs posted in conspicuous places at the entrance to the same. Overnight parking is prohibited. **Exceptions to this section include: Loading and unloading of watercraft at parks specifically designated for afterhours boat ramp use;** and utilization of parks with lights for sponsored events until 9:30 p.m., at which time the lights must be extinguished. No overnight parking allowed at James Lee Park from 11:00 p.m. Central Time until one hour before sunrise. Violators will be towed at the vehicle's owner expense. No umbrellas or tents shall be on the beach between the hours of 12:00 a.m. and 7:30 a.m. This is to allow for proper cleaning and inspection of the beach. This section does not apply to the Pier and Newman C. Brackin Park.

Problems & Concerns cont'd I have lived next to the boat ramp since 1977. We were met with serious concerns once we moved in. Our lot was called "Devil's Den." There were week-end parties with a range of fifty -seventy-five kids. Stoned from drugs and or alcohol. At first it was like watching AFV. The sheriff would bring his dogs, make some arrests and the rest of the group would scatter. But the drugs and kids kept returning. They would use my back garage bathroom, leaving their feces & vomit for me to clean up. They would tear off my mailbox cover and throw nails & glass on my garage apron. I electrified my fence, which prevented them from entering my yard. On two separate occasions, I had females come to my door at 2am, asking to use the phone. Their boyfriend had either tried to rape or beat them. One evening Dave & I heard a girl screaming. Her boyfriend was drunk & beating her. We ran down to intervene & I immediately recognized one of the boys. I told him I never wanted to see him again at the park, because I would call his mom. Things seemed to settle down after I talked with a few of the kids. I began to recognize them in the neighborhood & told them I would have no problem confronting their parents. They told me the police were afraid of them & asked, "Why was I not afraid?" I told them I grew up around the Mafia, and a few punks were not going to take my neighborhood. Being from South Chicago, I knew this would be an uphill battle. I had to leave one neighborhood for drug & gang activity, I wasn't going to give up without a battle. Drug dealers are like bed bugs: once you let them in, they're tough to get rid of.

I personally know a dozen families in this neighborhood, whose children & grandchildren have been affected by drugs. They have died, served jail time or are permanently brain damaged. Being a mother and a retired teacher, I will not have drugs within walking distance from Longwood School or my house. One neighbor said, "Drugs are everywhere. So big deal." So that means I must accept it? Most everyone in Poquito Bayou knows of the drug issues at the ramp. There was initially a sign that read, "Only boat traffic allowed after 10pm". It's gone. As well as Okaloosa County Sheriff's Dept. total support in maintaining law and order. We have called on numerous occasions, and the response was spotty at best. One officer wrote a ticket, for illegal parking in a handicapped spot (for which we called). We were told by the Sheriff's office, "They had better things to do than write tickets to law abiding citizens. The officer should not have written the ticket." **So why have the sign?**

I really don't mind the boat traffic as much as the drugs, alcohol, speeding cars & loud music. Not sure you can have one without the other. Unless the Sheriff's office is willing to do more patrolling. Boat traffic is only about 5% of what I see down here at night. How long do I have to put up with the illegal nonsense? I will try to protect my neighborhood from the bed bugs & lice, for the sake of the youth who like to use the park. But I can't do it alone.

Question: Would you be willing to tolerate all the illegal and potential activity that goes on down here on a regular basis?

I'M NOT.

CAN WE SOLVE THE PROBLEMS AT THE PARK?

The following picks up on the discussion(s) at the park on Sunday afternoon. What can we do to expand our neighborhood watch to include the park? We need to be more pro active in identifying potential illegal/illicit activity.

Someone brought up the idea of if you're going home late at night, swing through the Poquito Boat Ramp Park on your way home. Your presence may break up some illegal activity.

I briefed everyone that I sent an email to Amanda Maxwell, Okaloosa County Finance & Administrative Manager, Facilities and Parks Maintenance requesting cameras be installed to help monitor activity at the Poquito Boat Ramp Park. I asked who monitors the video feed and how secure are the cameras against vandalism. I plan to ask in a follow-up email about the park lights not being on at night.

I got a response to my email from Butch Hendrick, Facilities and Parks Maintenance Director for Okaloosa County. He advised the following: We do not utilize cameras because we have no one to monitor them. He advised that in the past some dummy cameras were installed and did not last due to vandalism.

Prior to the meeting I was sent a text regarding park use hours. I read it to those attending the meeting. Afterwards, I posted it on the Poquito Community Facebook webpage.

I plan to email my wife's letter to Sheriff Aden asking what they can do to help deter crime instead of some beefed up patrols for the next two weeks.

One recommendation was for everyone to sign a petition requesting the county to take some type of action regarding this serious community matter.

If you have any ideas on how we as a community can make the Poquito Boat Ramp Park a safer place for everyone, please let me know. Thanks,

In attendance were Dave Hensley, Tricia Flaherty, Pam Martin, Bob Davis, Lendy Edwards, Mary Ann Leone, Kiki Higginbotham, Tracy Mankowich, Keith Myers, Mrs. Matt Murphy, guests Mr. & Mrs. Pelfrey and son Chase Pelfrey, who departed after Chase's presentation.

Dave introduced Chase Pelfrey, a local Boy Scout who will be making three benches, a new sign, and corn hole boards for Leo Norred Park as his scouting Eagle Project. He described some of the materials needed, estimated costs and what they would look like. The board was extremely pleased and look forward to hearing about Chris's progress with the project.

Minutes of the August 2 meeting had been distributed; motion to approve was made by Pam and seconded by Bob, minutes were approved. Treasurer's report for August 31 was presented by Tricia; motion to accept by Kiki, seconded by Bob, report was accepted.

Emergency Action & Neighborhood Watch: No report, vacant

Leo Norred Park: Dave reported that he, Lendy, and Don Kreis had examined the fencing and determined its needs.

Welcome: No report

Membership: Pam verified 114 paid members.

Children's Party Coordinator: Kiki will have the festival type of event from 2-5 pm on Sunday, October 31, followed by Trunk or Treat while it is still light. She needs volunteers to plan and work the event, and provide some homemade treats.

CERT: Tracy gave an extensive report on planning: volunteers need to be trained and she has found a person in Longwood who is a trainer and will help; she has extended the scope of CERT activity too Hands Cove, Woodland Shores, Longwood, Paradise Point.

Poquito Boat Ramp Park: Keith gave an update on the park/dock renovation and discussion followed on the recent Board of County Commission installing a new sign advising the park's closing from Dusk to Dawn and a gate locking the park for use in daylight only. As there are now two opposite sides, one for and one opposing the closure, both sides were briefly discussed. It was the consensus of the board that PBCA will not have a position, as there are members on both sides of the issue.

Street & Traffic Safety: Bob reported that he has had people asking about having rumble strips installed (no locations mentioned), no action taken after brief reminder of history's opposition to same.

Street Directors: Dave still needs help with welcome letter revision/update.

Old Business: Discussed under Keith's report on Boat Ramp Park.

New Business: (1) Pam reported on the project of a new sign for the Poquito Bayou subdivision. Lendy has been working with Don Rosicka, a professional stonemason and resident, who has agreed to build the sign. Specific design, cost, etc. will be forthcoming, which will require time and fundraising, but will be a beautiful community asset. (2) Chase Pelfrey will work on the Veterans Memorial sign as part of his Eagle Scout project for us. (3) Ken Leone is working on the Veterans Memorial flag case. (4) PBCA General Membership Meeting in October, date to be decided, will be at Leo Norred Park. Annual Budget to be presented, and Election of new board officers.

Announcements: Newsletter articles for September articles due to Bob Davis is **September 12**. Issue will be published on Sept. 15. Next meeting is Monday, October 7 and new location is now required, need volunteer!


